SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. For persons with no symptoms, call the Toxicological Information Centre to decide about the need of medical treatment; provide information about the substances or composition of the product from the original packaging or the Safety Data Sheet of the product.
